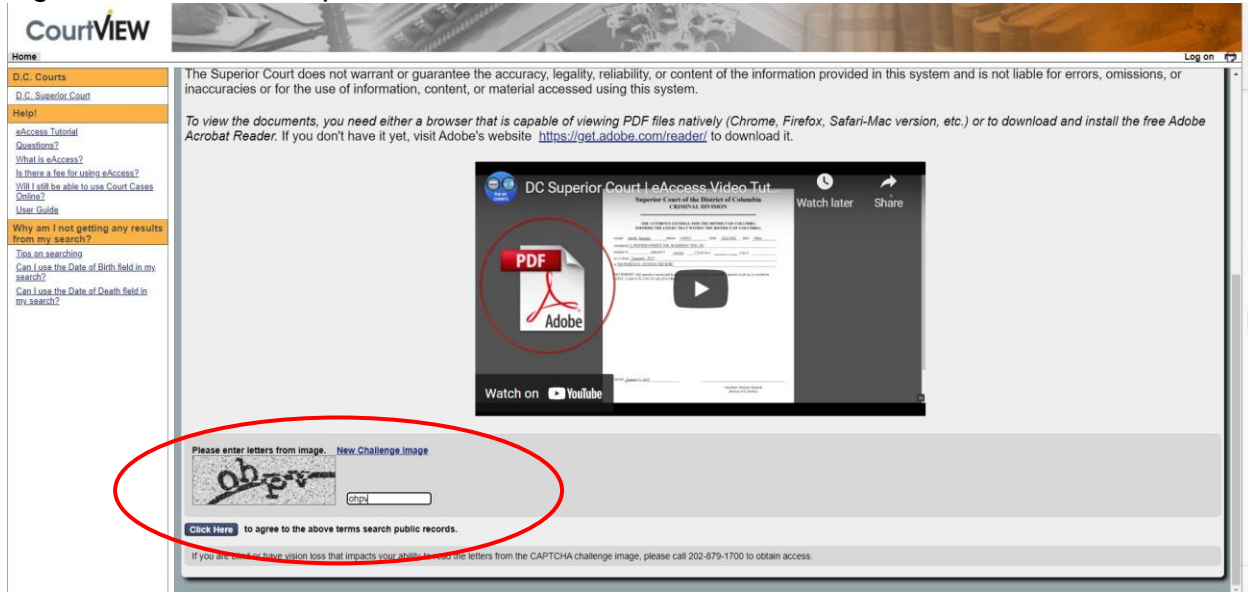


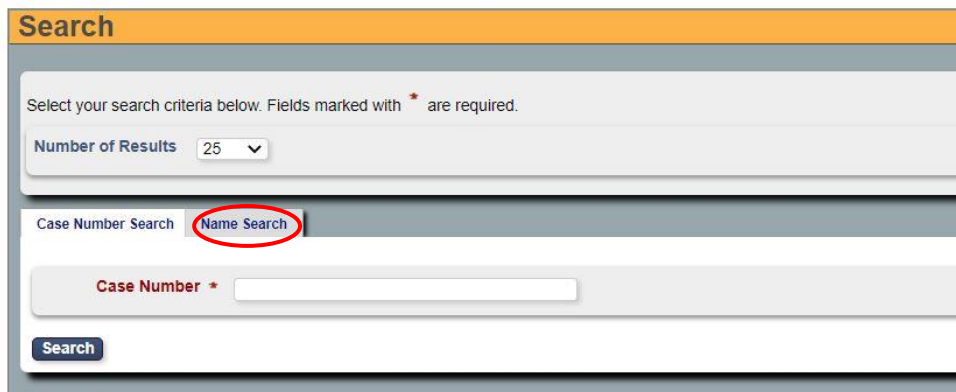
# Accessing Mortgage Foreclosure Information via e-Access

1. Go to the e-Access [website](#).
2. Enter the letters in the **challenge image** and select “**Click Here**”. No additional login information is required.
