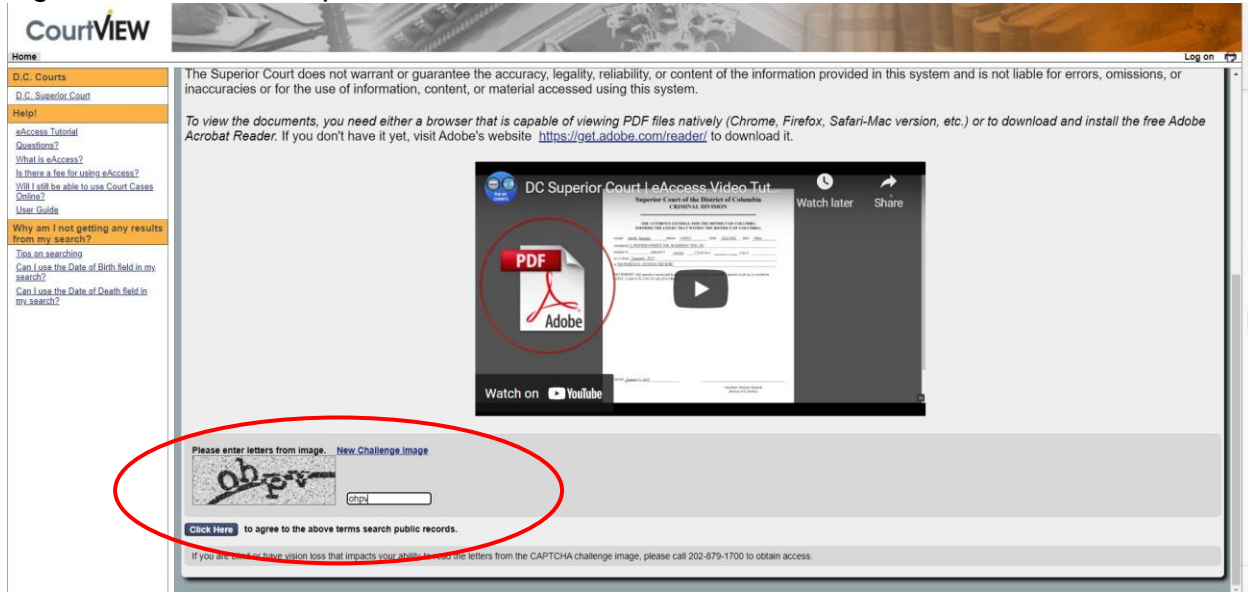


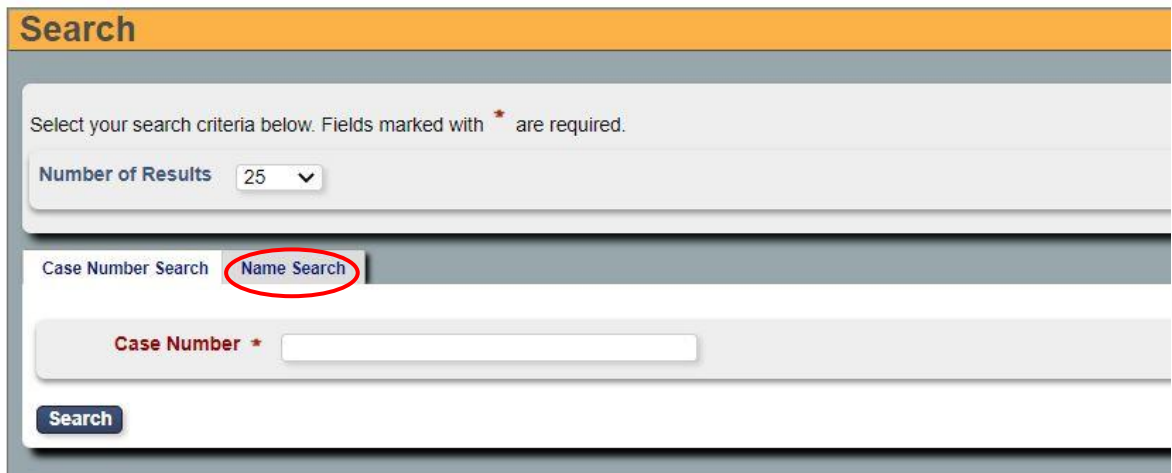
# Accessing Tax Foreclosure Information via e-Access

1. Go to the e-Access [website](#).
2. Enter the letters in the challenge image and select **“Click Here”**. No additional login information is required.



3. Select the **Name Search** tab.

- In the list of search results, look for the cases with the suffix **L(RP)** or **Case Type Title 47**. Find the case with the Case Status that is **Open**. Select the case with the suffix L(RP), case type Title 47, and the Case Status is Open.
